MEETING MINUTES

SEWERAGE AND WATER BOARD OF NEW ORLEANS

ROLL CALL

The Board of Directors for the Sewerage and Water Board of New Orleans (SWBNO) met on Wednesday, October 26, 2022, at 9:08 AM in the Executive Boardroom. Special Counsel Ms. Yolanda Grinstead called the roll and confirmed the following members were present: Hon. APPROVAL OF PREVIOUS MINUTES

Prior to beginning the meeting, Tyler Antrup, Director of Strategic Planning, presented the Rate Adjustment & Affordability Overview. This overview focused on the kickoff of the formal "ratemaking" process, which will propose a specific plan with rates in January. Mr. Antrup and team have run several scenarios based on need and cost of service. The proposed increase will be based on those elements PLUS public input and feedback. The utility will continue to diligently seek resources such as (WIFIA, IIJA, HUD); but they are smaller, single-project revenue pots that do not provide stable, long-term financing. The study is now complete and has provided the baseline cost of service for our customers, analysis of operating and capital needs for water/sewer systems, affordability considerations, and rate adjustment scenarios. Mr. Antrup stated the goal is a balanced, well-supported plan focusing on stability and resiliency.
