SEWERAGE AND WATER BOARD OF NEW ORLEANS

ROLL CALL

The Board of Directors for the Sewerage and Water Board of New Orleans (SWBNO) met on Wednesday January 25, 2023, at 9:10 AM in the Executive Boardroom. Mayor Cantrell presented a motion to accept the minutes of the December 14, 2022, Board Meeting. Director Lynes Sloss moved for approval of the minutes. Director Robin Barnes seconded. The motion carried.

REPORT OF THE EXECUTIVE DIRECTOR

Executive Director Ghassan Korban started his report by introducing the new Chief Auditor Edwin Sutterland. Mr. Korban stated Mr. Sutterland brings the utility vas amount of experience in the audit world and will hold a unique position at this utility. Mr. Korban also introduced the new Deputy General Superintendent Mr. Steve Nelson. Mr. Nelson is going on his third week with Sewerage and Water Board and doing an outstanding job. Mr. Korban stated Mr. Nelson is responsible for networks and gar engineering and acknowledge Mr. Nelson for stepping up and deescalating plenty of ongoing issues.

Executive Director Ghassan Korban and General Superintendent Steve Nelson recognized Mr. Alvin Jackson from networks on his observed good work in serving the community. Mr. Jackson was presented with a Sewerage and Water Board metal for his awesome and proud service. Executive Director Ghassan Korban presented a slide overview that focused on the following topics:

Director Alejandra Guzman and Director Maurice Sholas expressed how the smart meter customer portal is important for Sewerage and Water Board. This portal is a big deal with communication to the community, customer service and operation effectiveness. The big response is that the customer screen and employee screen will look exactly alike. Director Sholas stated it is a very important matter and a relief to the community for them to see same screen portal. This progression is a direct response to the consumer response in making the system better and also responds to people who felt they haven't been heard.

Mayor Cantrell acknowledges this achievement has come from making tough decisions to have the resources to get where this utility is today. Mayor Cantrell stated this is where partnership really makes a difference, when we are acknowledging the progress every step of the way. Director Guzman reinsured this not a product in a couple of days but years in the making and the public can finally see the progress. Mayor Cantrell stated the city received the 7 million of reimbursements from FEMA. 2 million dollars aligned with COVID and 5 million dollars aligned with hurricane Ida. These reimbursements are starting to come forward.
