The Finance and Administration Committee met on Wednesday, November 8, 2023, in the Executive Boardroom. The meeting convened at approximately 9:05 A.M.

#### 1. ROLL CALL

#### 2. CASH FLOW OVERVIEW

Mr. Grey Lewis, Chief Financial Officer, presented an update on the September 2023 financial results and liquidity position, as it is critical that SWBNO maintain sufficient cash flow levels to continue operations, and meet bond covenant requirements. The September 2023 Water and Sewer cash levels (224 and 255 Days Cash on Hand, respectively) exceed the minimum and target thresholds based on month end cash and budgeted expenses. Additionally Debt Service Coverage is within the budgeted forecast. October collections were \$23.5m after September totaled \$22.3m for the month with the FY23 Monthly average thru October being \$21.7m. Past Due Accounts receivables as of September 30, 2023 (aged > 60 days) were \$53.4m a decrease of 1% or \$0.4m from the prior month end.

September billed revenues (\$22.2m) were below budget (23.1m) by approx. \$900k while YTD revenues (\$209.5m) exceeds budgeted (\$208.2m) by \$1.3m. Drainage Tax revenues for the year (\$67.9m) are on budget and Other non operating revenues are higher in FY23 by approx. \$6m due to interest income from higher fixed interest rates on invested funds. September operating expenses (\$24.3m) were lower than budgeted for the month based on conservatively budgeted amounts and approximately the same as operating expenses a year ago (\$24.2m);

YTD operating expenses are \$248.3m which is less than conservatively budgeted \$310.9m thru September; management will continue to monitor.

The F&A committee also received an update on Customer Service Statistics -- Call Volumes, Customers Served and Customer payments were lower in September. Total bills issued were 133,236 with annual trend indicating additional consistency in total bills issued monthly with the alternative meter reading strategy. Open customer bill disputes decreased slightly at the end of September to 4,728 from 4,787 last month. Average days to close a customer investigation decreased to 121 days from 129 days last month with continued focus being placed on improving the processes. Consistent collections practices continue to be a primary focus with the collection ratio over last twelve months ended September 2023 (3.7% uncollected) dipping slightly relative to the last twelve months ended September 2022 (3.1% uncollected).
